I. WELCOME

Judy Shanley and Todd Hansen welcomed all attendees to the committee meeting and introductions were made.

II. COMMITTEE ANNOUNCEMENTS

Todd led a brief remembrance for Dr. Cecilia Feeley. Attendees were invited to speak and share remembrances.

Judy spoke about the Committee's Blue Ribbon Award. AME50 was awarded a Blue Ribbon by the TRB Technical Activities Council under the category of "Implementation: Moving Research Ideas into Transportation Practice" for the active and meaningful engagement of individuals with disabilities enhancing the movement of research to practice and creating opportunity for systemic change across the transportation research field.

A certificate of recognition was presented to Dr. Trevor Hanson for serving as the committee research coordinator from 2016-2023.

We are currently in the second year of the three-year member rotation. AME50 aims to have diverse representation. TRB is moving to enforce membership rules, including a maximum of three terms per committee. This includes non-consecutive terms. TRB is also ending the emeritus program. However, current emeritus members will retain their status.

III. COMMUNICATION REPORT

Susan reminded everyone that AME50 puts out quarterly newsletters and explained the protocol for making submissions. The <u>newsletters and protocols</u> are available on our web site. Guest contributors are welcome, please reach out to <u>Susan</u>, <u>Judy</u>, or <u>Todd</u> with any interest.

Attendees were reminded of our <u>website</u> and that it can be used as a resource. Subhash has been updating and enhancing our web site to include more information and make it user friendly.

III. HAPPENINGS AT THE Annual TRB Meeting

Chengbo reported that a total of 39 papers were assigned to our committee with 24 accepted for presentation and three for presentation and transferred to TRR review. Most of the papers had three reviewers. Topics included older populations, on-demand mobility and technology, public transit and paratransit transportation, pedestrian accessibility and trip planning, and case studies and implementations. The following were recommended for publication:

- Understanding Perceptions of College Students on Operation of Automated Shuttle for Persons with Disabilities on Campus Walkways
- Investigating Unfulfilled Travel Needs for People with Travel-Limiting Conditions using the 2017 NHTS data
- Community Public Mobility Using On-Demand, Low-Speed Electric Vehicles: A Case Study in Downtown St. Louis, Missouri

- Travel Barriers to Accessibility and Practices in Improved Americans with Disabilities Act Implementation
- Older Adults, Travel Options, and Barriers to Accessibility

IV. TRANSED CONFERENCE

Judy noted that a conference is planned for 2025 but that may shift depending on planning efforts. We have robust planning committee and welcome anyone who would like to join. The intention is for the conference to be held outside of the U.S. and AME50 is working with TRB to clarify its role in the conference.

The committee is working to identify partners who can help plan an international event. There is a flyer available with information for potential partners. If you are aware of any potential partners, please reach out to <u>Judy</u>. Partner organizations should be aligned with the purposes of AME50 and TRANSED and would need to be able to provide monetary support up-front to advance the conference.

Attendees provided some suggestions, such as not dismissing the notion of a virtual conference considering AME50's membership and difficulty with travel for some. It was also suggested that the conference could benefit from a reimagining and update to its current format, such as focused round tables on one-two issues rather than generalized research. The International Transportation Forum format was provided as an example.

Judy welcomed suggestions regarding experiences with other conferences that could be considered.

V. UPDATE FROM KELLY BUCKLAND

Kelly Buckland, Disability Policy Advisor at the U.S. Department of Transportation, gave a brief update on the USDOT's disability policy priorities and noted that these can be found on the DOT's web site, along with the passenger Bill of Rights. Kelly also noted that eight new attorneys have been hired to deal with complaints and reduce the backlog. See slides on TRBaccessmobility.org site.

VI. TRB BUSINESS ITEMS

It was noted that this year's registration for the TRB is likely similar or better than last year's with approximately 12,000 registrations.

The research needs database now resides on the MyTRB platform. This year, more than 6,500 papers were received and there is some concern about the rising number, particularly as many (approximately 2,000) came in at the very end of the deadline, which makes them difficult to process and review. TRB is looking for feedback from committees on how to address this. This is less of a concern for AME50 which receives a relatively small amount of papers.

TRB advised that friends of the committee should receive an email in April to refriend the committee or risk being dropped from the list as TRB is updating its lists and will be doing a purge. Please make sure to go into your MyTRB account and refriend the committee if you wish to remain on the list.

VII. TRANSIT DATE EQUITY INITIATIVE

Suresh Devalapalli from Gaussian Solutions spoke about the Transportation Data Equity Initiative. The goal is to create, modify and improve data standards and data

tools necessary to provide mobility benefits more equitably. For more information, the presentation deck is available in the meeting materials folder.

The goal of the task force is to get funding towards the research topics we think are important and to get Research Statements selected by TRB's cooperative research programs. The task force will identify priority areas for research topics; select research topics for statement development; organize and sustain mini-teams to co-write statements; obtain co-sponsorship from other committees and endorsement from stakeholder organizations; and submit Research Statements by the deadlines.

- Benito Perez Accessible Streetscape Project there is no deck for this in the meeting materials folder; summary below:

All people in a community rely on the transportation network to get from point A to point B in the interest of living, working, and playing. However, the system historically has not been designed to benefit all users equally. More specifically, there are design and planning considerations that have not been wholly considered, resulting in adverse consequences to the physical mobility plus the interactive and safe use of streetscapes for people with disabilities. Those design and planning considerations have proliferated over the years for various reasons and context, but boil down to a lack of awareness of the concept of inclusive accessibility and the real life implications to end users (understanding "to walk in their shoes").

Deliverables:

- Resource guide exploring streetscape accessibility from mobility, vision, hearing, cognitive ability, and language barrier perspectives. Exploring from conceptualization, community engagement, design, construction, and maintenance of the streetscape for accessibility.
- Federal advocacy push for a transit ready communities <u>legislative idea</u>, aimed to push for standards development, discretionary and formula funding to facilitate accessible streetscapes, and support land use and zoning innovation.
- Development of accessible streetscape guidelines for incorporation into <u>NACTO's Urban Street Design Guide</u> and other related enforceable guidelines.

Volunteers and support for the development of this project is being sought, specific asks include:

- Peer reviewer of an end user survey (<u>PDF</u> and <u>surveyMonkey</u>), due to go out this spring (tentative mid March 2024 for 60 days)
- Assistance in distributing the end user survey across the country/internationally
- Peer review of the literature / best practices catalog
- Peer reviewer of the resource guide, later in 2024
